**No.EDN/RTE-227/2011/41:-** In pursuance of Section 14 of the Right of Children to Free and Compulsory Education Act, 2009 read with Rule 9 of the Meghalaya Right of Children to Free and Compulsory Education Rules 2011, the State Government does hereby prescribed the documents for determining the age of a child for the purpose of admission to elementary education, institutions as follows:-

**Documents as age proof for the purpose of section 14 –**

Wherever a birth certificate under the Births, Deaths and Marriages Certification Act, 1886 is not available, any one of the following documents shall be deemed to be proof of age of the child for the purposes of admission in schools –

- (a) Hospital / Auxiliary Nurse and Midwife (ANM) register record
- (b) *Anganwadi* record
- (c) Declaration through an affidavit of the age of the child by the parent or guardian.
