SECTION -II

General Condition of Contract (GCC)

1 BACKGROUND

1.1 - Education Early Childhood Care and Education (ECCE) is an integrated program of nutrition, health and pre- primary education for children 3 to 6 years of age. According to UNICEF, early childhood care and education (ECCE) aims at the holistic development of a child's social, emotional, cognitive and physical needs in order to build a solid and broad foundation for lifelong learning and well-being. Evidence from neuroscience shows that over 85% of a child's cumulative brain development occurs prior to the age of 6, indicating the critical importance of appropriate care and stimulation of the brain in a child's early years for healthy brain development and growth. It is therefore of utmost importance that every child has access to quality early childhood care and education (ECCE).

ECCE ideally consists of flexible, multi-faceted, multi-level, play-based, activitybased, and inquiry-based learning, comprising of alphabets, languages, numbers, counting, colours, shapes, indoor and outdoor play, puzzles and logical thinking, problem-solving, drawing, painting and other visual art, craft, drama and puppetry, music and movement. It also includes a focus on developing social capacities, sensitivity, good behaviour, courtesy, ethics, personal and public cleanliness, teamwork, and cooperation. The overall aim of ECCE will be to attain optimal outcomes in the domains of: physical and motor development, cognitive development, socio-emotional-ethical development, cultural/artistic development, and the development of communication and early language, literacy, and numeracy. (NEP **Para 1.2**)

Provision of Teaching Learning Materials such as toys to children at the foundational stage of growth can help in for developing cognitive and psychomotor skills, learning skills (such as, critical thinking, creativity, problem-solving, etc.) ethics and values, life skills (such as environmental awareness, courage, hygiene, communication, etc.), etc. The toy-based pedagogy should henceforth become an important aspect of experiential learning from early stages right up to primary level.

The State Project Office has taken many efforts and innovative practices to enhance the learning levels and skills of the students across the State. This provisioning of Teaching Learning Materials in the schools is also another visionary attempt to enhance the understanding and learning skills of the students. By the use of these items the students will be able to touch, feel, analyze and visualize the processes, by combination of many items in the learning materials. The TLM will also provide an enable an environment for the students to learn while playing with different items in the learning kit.

- 1.2 1)Language Learning Material Kit: Main aim of the Phonetics / Language Material is to facilitate students to learn the professional communication and correct phonetic. 2) Toy-Based Learning, Activity Based Learning Kit: Activity-based learning is

the process of learning by doing. Activity-based learning kits/ techniques encourages



students to actively participate in learning in their own way through practical activities such as problem-solving, creativity, independent analysis etc.

- 1.3 Pre-primary/ECCE Kits As per NEP 2020, the uncovered age group of 3-5 years is recommended to be brought under school curriculum, which has been recognized globally as the crucial stage for development of mental faculties of a child. Availability and accessibility to variety of materials can support the child's holistic development which includes physical and motor skills, cognitive skills, language and communication skills, socio-emotional development and creativity.
- 2.1.1. The PAB, Ministry of Education, Government of India has approved allocation of Rs 500/- per child for TLM, (Pre-primary recurring - 134.4 TLM for Children), for implementation of innovative TLM for Pre-Primary schools in the State.
- **3.1.1** The Agency/ Organisation is required to collaborate with the State Agencies- DERT, SSA to fit the state requirements.
