A. General:

a) The notice inviting quotation can be downloaded from State Project Office Samagra Shiksha Govt. of Meghalaya website at www.ssa.megeducation.gov.in.

B. Eligibility/Qualification Criteria:

- a) Must be authorized and registered as per E-waste Management Rules, 2016, as a Dismantler /Recycler/Refurbisher/ Producer Responsibility Organisation of e-Waste with Central Pollution Control Board, Ministry of Environment and Forests, Government of India or with the State Pollution Control Board or State Governments dealing with E-waste etc.
- b) Bids received from the firms other than so registered will be summarily rejected. Must not be blacklisted by any Department of the Government of India or of any State/or by any PSU/Autonomous Organization of Government. An Undertaking regarding non-blacklisting of the bidder by any Government Organization must be furnished by the bidder in the tender document in the format given in **Annexure-D.** Bids without above undertaking will not be considered.
- c) Should be registered with GST/ Service Tax/VAT with Departments of Government of India/State Governments

C. Period of Validity of Bid

The bid shall remain valid for 90 days after the date of bid opening. If any bidder withdraws their quotation before the said period shall without prejudice to any other right or remedy, State Project Office Samagra Shiksha be at liberty to forfeit the Bid Security absolutely.



D. General Terms and Conditions

The bidders may inspect the items on a predetermined date as given in Bid Schedule and satisfy themselves about the items they are bidding for.

- a) The items shall be sold to the highest bidder.
- b) The Earnest Money Deposit of the successful bidder shall be return within 2 months of awarding the contract. The EMD of unsuccessful bidders shall be returned within one month of publication of successful bidder, without any interest.
- c) No items, once disposed off to the successful bidder, shall be taken back by the office of State Project office Samagra Shiksha, Govt. of Meghalaya.
- d) The successful bidder must make full balance payment in the form of Demand Draft in favour of the State Project Director, Samagra Shiksha Government of Meghalaya, failing which the offer will be cancelled and EMD shall stand forfeited.
- e) An Earnest Money Deposit (EMD) of 10% of bid value must accompany each quotation. This shall be in the form of Demand Draft/Pay order of any Nationalized / Scheduled Bank drawn in favor of **State Project Director**, **Samagra Shiksha** payable at Shillong, without which the tender shall be summarily rejected. **Cheque/Money order/ Cash shall not be accepted**. The EMD deposit shall not attract any interest.
- f) The successful bidder (vendor) shall be required to lift all the items from the disposal site to their premises within 3 (Three) days after the payment of the quoted amount. On failure to do so, office of State Project Office, Samagra Shiksha shall have the right to forfeit the entire amount of the bidder and dispose the items to an alternate bidder.
- g) The successful bidder shall deposit the total calculated amount based on their quoted rates within 3 days of receipt of letter/ e-mail communication from State Project Office, Samagra Shiksha, Government of Meghalaya. A copy of this document (terms and conditions) with each page duly signed by the authorized signatory, who has signed the bid, should be submitted with the quotation in token of acceptance of the terms and conditions.
- h) Incomplete and unsigned quotations will be rejected.
- i) The Successful bidder need to submit an undertaking that all the e-waste will be disposed off as per E-waste (Management and Handling) Rules notified by Ministry of Environment & Forests, Govt. of India.

E. Bidding Procedure:

- a) Sealed Bids shall be received, not later 3.00 P.M on 11th November, 2023. No Bid will be accepted after this date & time under any circumstances. This office will not be responsible for any postal/courier delay and for reasons beyond the control of this office.
- b) All bids must be delivered to the office of State Project Director, Samagra Shiksha, Government of Meghalaya, Shillong-793001,



c) All relevant rules and regulations of Government of India will be final and applicable & binding on all bidders.

F. Submission, opening and evaluation of Bids:

- a) The bid should be submitted in two separate sealed envelopes for,
 - 1. Pre-Qualification/ Technical bid and
 - 2. Financial bids.
- b) The bidder shall submit their bid in the prescribed proforma enclosed as Appendix - I
- c) The amount should be quoted in Indian Rupees and should be clearly legible. In case of any ambiguity, State Project Office Samagra Shiksha, Government of Meghalaya shall have the authority to reject the bid.
- d) The amount must be quoted in figures as well as in words. In case of any inconsistency in the rates quoted in figures and words, the rates quoted in words shall be taken as correct.
- e) Any over-writing/cutting/fluiding should be authenticated by the signatures of the individual who has signed the bid. Non-adherence to the same will lead to rejection of the bid.
- f) A copy of the terms and conditions (with each page duly signed by the authorized signatory signing the bid) must be attached with the Proforma containing the rates quoted.
- g) All the bids must be accompanied by a bid security (EMD) of the amount 10% of bid value in the form of a Demand Draft issued by any Nationalized Bank in favour of **State Project Director**, **Samagra Shiksha**, payable at Shillong. Bids received without EMD shall be summarily rejected.
- h) A copy of Certificate/Proof of Registration with Central Pollution Control Board (CPCB) or Pollution Control Board, Meghalaya should also be submitted with the Bid, failing which the Bid will be rejected.
- j) The proforma containing bids along with Demand Draft towards EMD, a copy of certificate of Registration with Central Pollution Control Board and a signed copy of terms and conditions should be sealed in a Cover super scribed with the words "Bid for E-Waste" and send to the State Project Director, Samagra Shiksha, Government of Meghalaya, Shillong-793001 to reach the addressee latest by the date and time indicated in this Document.
- k) No bid may be modified after the deadline for submission.
- The Bid shall be awarded in favour of the bidder quoting highest price. The highest quote would be arrived at after considering the prices quoted for all items and not item by item rates. In case, where a bidder quotes lump sum amount for complete e- waste proposed for disposal under this tender and the same is found to be the highest value tender, such bidder shall be awarded the bid.
